1. Whether there were shortcomings or failures in the decision not to detain Kaine under s.136 Mental Health Act 1983 on 2 July 2022

In considering this issue, please specifically consider:

- (a) Any shortcomings or failures of the police
- (b) Any shortcomings of failures of the mental health trust.
- 2. Whether the guidance given to the Street Triage Team to conduct a mental health state assessment was adequate
- 3. Whether Kaine was exhibiting signs and symptoms of Acute Behavioural Disorder on 2 July 2022
- 4. If you consider that Kaine was exhibiting symptoms suggestive of Acute Behavioural Disorder on 2 July 2022, whether there were any shortcomings or failures in identifying these symptoms.

- 5. If you consider that there were shortcomings or failures in relation to any of the issues above, did these shortcomings or failures lead to a missed opportunity for Kaine to undergo a Mental Health Act Assessment.
- 6. If you consider that there were shortcomings or failures which led to a missed opportunity for Kaine to undergo a Mental Health Act Assessment, do you consider that this more than minimally contributed to his death?
- 7. Whether there were shortcomings or failures in the decision of EMAS not to convey Kaine to the emergency department on 2 July 2022 as a result of his observations

Issues relating to 3 July 2022

8. Whether there were any shortcomings or failures in the decision and exercising of the police powers to detain Kaine s.136 Mental Health Act 1983 on 3 July 2022

In considering this issue, please specifically consider:

- (a) The timing of the detention;
- (b) What PC Bodle said to Kaine when she detained him;
- (c) How the police spoke to Kaine when restraining him;
- (d) The decision not to call an ambulance at the point of detention;
- (e) The decision to use force to compel Kaine to get into a police car;
- (f) The use of handcuffs and leg restraints;
- (g) The decision to try to restrain Kaine in the back of the police car;
- (h) The amount of force used and the circumstances in which, the police used force against Kaine, including striking him with fists, knees and a baton;
- (i) The restraint of Kaine on the ground before being put into the police van;
- (j) The use(s) of force to compel Kaine to get into a police van.
- 9. Whether Kaine was exhibiting signs and symptoms of Acute Behavioural Disorder on 3rd July 2022:
 - (i) At 2:05 a.m. (when PC Bodle and PC Thompson first met Kaine)
 - (ii) At 2:34 a.m. (when he was detained)
 - (iii) At 2:43 a.m. (when taken out of the car);
 - (iv) At 2:49 a.m. (when put into the van);
 - (v) At 2:56 a.m. (when removed from the van);
 - (vi) At 3.03 a.m. (when ambulance called).

- 10. Depending on what you have said in relation to whether you consider that Kaine was exhibiting symptoms of Acute Behavioural Disorder on 3 July 2022, whether there were any shortcomings or failures in identifying these symptoms and responding to them.
- 11. That in failing to call an ambulance at the point of detention, the police were in breach of a formal policy and their own working standards for s.136 detention
- 12. Whether in failing to call an ambulance the police officers on scene knew that they were in breach of a formal policy and their own working standards for s.136 detention
 - If the answer to this question is negative in its terms (*i.e.* the police officers did not know that they were in breach of policy) then please go on to consider:
 - (a) If the police officers had known about the policy and working standards, is it likely that they would have called an ambulance
 - (b) Why the police officers did not know about the policy and working standards. You may wish to consider whether this information was adequately communicated to officers.
